Mitigating Circumstances

The mitigating circumstances clause contained in the policy was invoked following assessment of performance data and announced on 2nd March. The International Panel has selected the top Women's C2 500m crew and will hold the second World Cup place open in WC2 500m. On 28th April there will be a single race off between the crew of Bethany Gill/Chloe Bracewell and the crew of Ruth Bennett /Afton Fitzhenry who finished second at the 14/15 April selection trials in this event. The winner of the race off will be selected to the World Cup team as second boat.
