Additional Information – Junior & U23 European & World Championships 2018

Since the publication of the 2018 policy, the event programme for these international events has been published. The International Panel wish to draw attention to the fact that the Men's K2 200m, Men's K2 500m and Men's K4 1000m will not be staged at these events. The purpose of stating this in this statement is to enable athletes to make an informed decision upon which events to target for selection.

In addition, now that the event programmes have been published, athletes thinking of doubling up in events are advised to speak to British Canoeing coaches to identify where any clashes may occur.
