DRAFT Canoe Sprint Junior Selection Policy 2024

This policy has been developed following the establishment of the <u>Junior Selection</u>

<u>Performance Advisory Group (JSPAG)</u> which brings representatives from clubs, communities and Home Nations together to propose the shape and direction of the junior selection policies. The Interim IP group have prepared the draft 2024 policy following the recommendations made by JSPAG and now share widely for public consultation.

The JSPAG and the IP proposals reflect the challenges of the timing of the International regattas, the dates of the domestic regattas and consideration of exams. Ideally the June regatta would provide the selection process for the Junior & U23 European and World Championships. Unfortunately there is insufficient time between the June regatta and the departure date for Europeans to complete the required preparation including bookings, appeals process etc. Therefore, the following recommendations have been made:

- Selection to the European and World Championships will take place over separate regattas (April and June respectively) to ensure teams have adequate time to prepare for the respective Championships and to allow more athletes more opportunities to be selected.
- There will be opportunities prior to the June regatta for Junior athletes to engage in a GB Crew Boat Process. This has no bearing on final selection, but will give athletes opportunities to come together to form crews and will be advised by Home Nation and Club Coaches. The predominant focus will be on K4 formation, however in future seasons, the aim is to provide more opportunities for athletes to build both K2 and K4 crews to challenge for selection.
- Any athlete who is selected to the European or World Championships will
 automatically be selected for Olympic Hopes. This is to reduce the overall number of
 regattas athletes may need to attend to try and ease pressure during school exam
 times, however, there will still be additional opportunities for athletes to qualify via
 the July regatta.
- Selection to Olympic Hope from the July regatta will be from both C1/K1 and C2/K2 events.

Introduction:

This year the racing calendar and policy has a multi-point selection that allows athletes to focus on selection for the competition(s) that they are targeting. The April regatta is a selection point for the European Championships and the June regatta for the World Championships. For those eligible athletes not already selected for the Olympic Hopes through selection to a 2024 championship team, the July regatta will be selection for the Olympic Hopes races. This allows athletes more choice on selection events to reduce the conflict between school exams and international racing and can use early season regattas for race practice in preparation for the selection regattas. There will be an emphasis on crew boat racing this year, and we encourage athletes to use all opportunities to develop crew boat skills. In recent years the Olympic Hopes competition has become a high quality unofficial age group World Championships. In response, we are changing our approach to selecting the team. This year the July regatta will be the sole selection point to select an U16 and U17 team, which will be based upon performances in C2 and K2 only. Athletes need to make sure that they do everything they can to keep injury and illness free and race at the relevant selection events. The IP will also be asking athletes to be clear on event priorities when contesting multiple events for selection.

SECTION A: PURPOSE AND PRINCIPLES

1. Purpose

The purpose of the Canoe Sprint selection policy is to clearly outline the processes which will lead to the selection of the GBR Junior Canoe Sprint Teams for all 2024 international events named within this policy. It also aims to support the longer-term goals of the sprint strategy to 2028 and 2032.

2. Principles

- 2.1. The primary focus of National Team Selection will be to optimise performance in targeted Olympic events and to support athlete development into high level senior performers.
- 2.2. The Selection Policy seeks to select the best athletes in a transparent way that prioritises optimal preparation time for achievement of international success.
- 2.3. Selection will be based on results in selection races and subject to an assessment of performance standards. All eligible athletes will be considered equally for selection against the stated selection criteria regardless of club, training location, age, Home Nation and programme status.
- 2.4. The Selection Policy provides opportunities to use unfilled event places for development opportunities.
- 2.5. Selections will be made in alignment to, and in support of, the Canoe Sprint Performance Strategy.

SECTION B. ELIGIBILITY AND PERFORMANCE STANDARDS

3. Eligibility

- 3.1. To be eligible to be selected to any 2024 GBR Team, athletes/crews must meet the following conditions (full detail can be found in British Canoeing's Eligibility Policy):
 - 3.1.1. Meet age and nationality criteria for international competitions as outlined below
 - 3.1.2. Be a full member of British Canoeing or Home Nation Association that enables participation in competition
 - 3.1.3. Athletes on a funded programme need to have signed their Programme Athlete Agreement. Athletes outside Programme funding will also be expected to sign up to the British Canoeing Great Britain Team participation agreement on accepting selection at least two weeks before travelling to the first competition and settle any outstanding payments prior to travel.
- 3.2. Where athletes compete in more than one eligible selection event, the policy will be applied in isolation for each specific event.
- 3.3. British Canoeing reserves the right to deselect an athlete who has been found guilty of a disciplinary offence under British Canoeing/ICF rules. This includes doping offences.

4. International Eligibility

- 4.1. Selection will be subject to eligibility in accordance with competition rules laid down by the International Canoe Federation (ICF) and the European Canoe Association (ECA).
 - 4.1.1. The first year a junior can compete at World and European Senior/U23/Junior Championships is the year of their 15th birthday.
 - 4.1.2. The last year a Junior may compete in the Under 18 category is the year of their 18th birthday.

5. Performance Standards

The International Panel (IP), will apply a performance standard for all selections under this policy to ensure athletes/crews are of the appropriate level for the competition they are being considered for. The detail of the application of performance standards can be found in Appendix 1. The IP reserves the right to not apply a performance standard either at all or as prescribed in Appendix 1, where circumstances arise which in the IP's reasonable opinion would make the application of the performance standard at Appendix 1 unsuitable.

SECTION C: GREAT BRITAIN SPRINT JUNIOR TEAM SELECTION 2024

6. Junior Team Selection Overview

- 6.1 Selection for the European Championships will be based upon performance at the selection Regatta on 13th/14th April at Holme Pierrepont.
- 6.2 Selection for the World Championships will be based upon performance at the selection Regatta on 8th/9th June at Holme Pierrepont.
- 6.3 Selection for the Olympic Hopes regatta will be based upon performance at the selection Regatta on 6th/7th July at Holme Pierrepont. Note- All athletes who are selected for the Junior Europeans and/or Junior Worlds team who remain U18 for 2025 are automatically selected to the 2024 Olympic Hopes team. 6.4 Team Selection for all events will be based on performances in the identified selection regattas.

2024 Junior Sprint International Competitions and Selection Announcements

JUNIOR EUROPEAN CHAMPIONSHIPS SELECTION

7. Qualification Criteria

- 7.1 Where athletes have been selected for multiple events, they and/or their coach will be asked to confirm which events they would like to be considered for and a prioritisation of these events prior to the relevant IP meeting. In this situation, an athlete or boat will be guaranteed selection in their first priority boat only. If an athlete wishes to be considered for multiple events the IP will at its sole discretion make a decision on which event(s) the athlete is selected for.
- 7.2 Subject to point 7.1 and an assessment of performance standard, the highest ranked available boat in the events in Table 2 at the April 13th/14th regatta will be selected to the European Championship team.

Up to two athletes finishing within 104% of a winning selected athlete will be named as a reserve for the Junior European Championships.

JUNIOR WORLD CHAMPIONSHIPS SELECTION

8. Qualification Criteria

- 8.1 Where athletes have been selected for multiple events, they and/or their coach will be asked to confirm which events they would like to be considered for and a prioritisation of these events prior to the relevant IP meeting. In this situation, an athlete or boat will be guaranteed selection in their first priority boat only. If an athlete wishes to be considered for multiple events the IP will at its sole discretion make a decision on which event(s) the athlete is selected for.
- 8.2 Subject to point 8.1 and an assessment of performance standard, the highest ranked available boat in the events in Table 3 at the June 8th/9th regatta will be selected to the World Championship team.

Up to two athletes finishing within 102% of a winning selected athlete will be named as a reserve for the Junior World Championships.

OLYMPIC HOPES SELECTION

9. Qualification Criteria

- 9.1 Subject to 9.3 the maximum team size will consist of up to 30 athletes in total (see table 4) which includes up to 6 Under 16 athlete places in each gender. This provides development opportunities for U16/15 Kayak Men and Women seeking international representation,
- 9.2 All athletes who are selected for the Junior Europeans and/or Junior Worlds team who remain U18 for the 2025 season are automatically selected to the 2024 Olympic Hopes team. Note it is the athlete not the boat that is selected. Clarification of those selected under this clause which will outline remaining places will be published following the June regatta.
- 9.3 In the case, that there are more than 4 U17 kayak athletes in a gender gaining automatic entry via selection for the Junior Europeans and/or Junior Worlds team (section 9.2), the total team size can increase in order to prevent a reduction in the number of U16/U15 athletes eligible to attend.
- 9.4 Subject to 5.1 any unfilled places that remain following the application of 9.2. will be allocated as outlined in Table 4. Where 2 or more spaces are available in an age category, priority one events will be used to fill the spaces. Single spaces remaining available will be filled through priority two events. Any remaining spaces will be filled through priority three events. Unfilled female spaces will be filled by female athletes and Unfilled male spaces will be filled by male athletes up to the numbers outlined in table 4.

- 9.5 Competition entries for all events will be finalised following the Olympic Hopes Camp at Holme Pierrepont on 8th-11th August 2024. Camp attendance is strongly advised for forming crew boats for events
- 9.6. Selected athletes wishing to race in singles events will be permitted subject to the process outlined in section 10.4.

SECTION D: GENERAL PROVISIONS, CONTINGENCY & EXCEPTIONAL CIRCUMSTANCES

10. General Provisions

- 10.1. The IP reserves the right not to nominate, or to de-select for the World and/or European Championships or any international event, any athlete or reserve on the following grounds:
 - 10.1.1. Medical grounds i.e. when an injury/illness may, in the reasonable opinion of the IP, inhibit the achievement of appropriate performance and/ or mean the athlete cannot reasonably be considered fit to travel; or

- 10.1.2. Suitability as a team member, where for example (but not limited to) an athlete's behaviour or attitude leads the IP to determine in its opinion that the selection of such athlete would be inappropriate; or
- 10.1.3. Poor form i.e. when an athlete's form in events and/or training has decreased to a level that, in the opinion of the IP, they would no longer be able to achieve the required level of performance to be competitive at the applicable competition(s).
- 10.2. Any decisions taken in accordance with 10.1 will only be made following consultation with the athlete, appropriate BC coaches and/or medical reports and in the case of 10.1.3 include reference to applicable performance standards.
- 10.3. Following the selection of a crew boat to the Junior World and/or European Championships or Olympic Hopes, the Senior Podium Coach must propose any changes to the composition of the crew due to injury, illness, poor performance or other circumstance to the IP who will consider the circumstances and determine an appropriate process to follow.
- 10.4. The Senior Podium Coach has discretion to use events within the Junior World, European Championship and Olympic Hopes programme that are unfilled for further start line opportunities that do not otherwise compromise performance. This must be communicated to the Chair of the IP in advance of the relevant competition commencing.
- 10.5. Up to two non-travelling reserve may be named in each event based solely on position in the identified selection race where performance standards have been achieved. In order of selection, named reserves will only travel in the event of injury or illness to a selected athlete or where a place(s) is declined. In the event of a team place becoming available either within 2 days of the team travelling to a camp or competition or after the team have arrived at a camp or competition, then the Performance Director at their absolute discretion may nominate a replacement but the decision will be final.

11. Contingency

- The IP retains the right to implement contingency measures where circumstances arise that prevent full, fair and competitive racing and adapt racing to ensure as fair a selection process as possible. This may include circumstances such as weather conditions and covid-19 implications.
- 11.2. The IP will monitor weather conditions ahead of a selection race, during the race and has a process for communication of real-time information.
- 11.3. If weather conditions or other significant issues arise making it inappropriate or impossible to conduct a selection race during or, in advance of competition, the IP may declare that a race(s) will not be used for selection and invoke one or more of the following non-exclusive alternatives:
 - 11.3.1. Rescheduling of any affected selection race(s) to early morning/ evening racing within the same regatta (if scheduling and weather conditions permit).
 - 11.3.2. Rescheduling of any affected selection races to an alternative competition (if appropriate)
 - 11.3.3. Rescheduling to a reserve date if available and appropriate.
 - 11.3.4. Amending lane draw for direct comparability of performances
- 11.4. Any decision made under these provisions of the policy will be made by a minimum of two IP Members and where possible, in consultation with the chief official.
- All IP announcements relevant to contingencies will be posted on www.britishcanoeing.org.uk. During competitions, important information will be posted at race control on the live results messaging, on the British Canoeing social media or messaging App.

12. **Exceptional circumstances**

12.1. Should an athlete miss a Selection event due to illness or injury during, or prior to, elements of the 2024 selection process; or have any other exceptional circumstances, the IP reserves the right to provide an opportunity for such a boat to be eligible for selection. For the purposes of this clause, exceptional circumstances are unplanned, unexpected, unavoidable and unforeseen.

 - 12.2. Where an athlete wishes to invoke this clause, exceptional circumstances requests should be directed to the IP prior to the commencement of the selection competition via email at enquiries.internationalpanel@britishcanoeing.org.uk and should provide:
 - 12.2.1. Certificated evidence of illness or injury, or other significant exceptional circumstance.
 - 12.2.2. Any evidence the athlete wishes the IP to consider which demonstrates in both training and racing, a superior performance level than other selected athletes.
 - 12.3. To be considered for an exceptional circumstances, an athlete must be able to demonstrate the following performance level:
 - 12.3.1. For Junior Teams, the athlete should have previously made a minimum of an A final result at the Junior World or Junior European Championship in the previous 24 months in that event or can demonstrate the equivalent level such as in the case of a crew boat.
 - 12.4. When considering whether an athlete meets the criteria outlined above, the IP will consider the following:
 - 12.4.1. The athlete's training and racing profile (from GBR performance analysis data);
 - 12.4.2. ICF World Ranking, Performance at Junior World Championship, Junior European Championship races within the previous 24 months.
 - 12.5. Where the IP accepts an exceptional circumstance request following the process detailed above, the IP reserves the right to:
 - 12.5.1. Identify a single race opportunity whereby the lowest ranked boat that has been selected and the identified athlete(s) would compete for a GBR Team place. If this situation arises more detail would be provided following the IP meeting immediately after the appropriate Selection race series.
 - 12.5.2. Where no athlete has been selected for the relevant event under this policy, accept the exceptional circumstances and select the athlete;
 - 12.5.3. Substitute the selection of the athlete under this policy with the selection of the athlete making the exceptional circumstances request
 - 12.6. All decisions under this Clause that relate to injury, illness (including Covid-19) or medical conditions will be determined by the IP members. When assessing if an athlete is fit to race, the decision of the IP is final.
 - 12.7. The IP has the sole discretion to invoke the provisions in this clause and any decision is final and not subject to appeal.

SECTION E: GENERAL INFORMATION

13. Responsibility

The Canoe Sprint IP, which is appointed by and reports to the Board of British Canoeing, is responsible for all aspects of developing, approving and managing the implementation of the Canoe Sprint selection policies. The Terms of Reference can be found here.

14. Conflicts of Interest

Any member of the IP shall declare any conflicts or potential conflicts of interest and shall refrain from participation in the discussion of and any vote in respect of any selection matter in which they have a material conflict of interest. If a person has any queries in this area, they should consult the British Canoeing Director of Governance.

15. Policy Changes

- 15.1. The selection policy may be amended at any time by British Canoeing for one or more of the following circumstances:
 - 15.1.1. Any changes in rules governing a particular event;
 - 15.1.2. Any change in ICF eligibility, rules or programme of events;
 - 15.1.3. To give effect to the selection process in case of a drafting error or oversight
 - 15.1.4. To clarify any ambiguity to the intended meaning of the selection policy

15.1.6. Circumstances arising from Covid-19

15.2. Any changes will be communicated on www.britishcanoeing.org.uk

16. Appeals Procedure

16.1. Certain decisions made throughout this Policy are not subject to appeal and where this is the case, specific reference will be made to the decision being final. For other selection decisions made under this Policy, the British Canoeing Appeals process applies and this procedure can be found here.

16.2. UK Sport funded World Class Programme athletes who require support and advice can contact the BEAA at support@britishathletes.org. the best interest of British Canoeing and in line with the principles outlined for selection

17. Data Protection

- 17.1. British Canoeing is a privacy conscious organisation and is strongly committed to an individual's right to privacy. All data gathered during the selection process will only be utilised for the purposes of an athlete's participation in a GBR Canoe Sprint Team. This may include administering their event/race entry and certain information may be published as part of the results and rankings of the event/race.
- 17.2. Any personal data will be processed and stored in compliance with the British Canoeing Data Protection Policy and in accordance with all applicable Data Protection laws in effect at the time of publication of this Selection Policy, including but not limited to, the Data Protection Act 2018 and UK GDPR.
- 17.3. Further information on British Canoeing's approach to privacy and data protection, including British Canoeing's privacy notices, policies and contact details, can be located in their Privacy Centre (https://www.britishcanoeing.org.uk/about/privacy-centre). Should an athlete wish any data British Canoeing hold relating to them to be deleted at any point; they should contact British Canoeing at GDPR@britishcanoeing.org.uk.

18. Policies

This Selection Policy operates in conjunction with all relevant British Canoeing policies including but not limited to, Equality, Anti-Doping Policy, Pregnancy, Safeguarding, Anti-Bullying Policy, Covid Vaccination Policy and Anti-Bribery Policy.

19. Communications

British Canoeing is committed to providing open and informative communication in relation to selection. All athletes will receive formal confirmation of the selection and for those athletes who wish to discuss the outcome of decision made by the IP, the Chair of the IP will be available to speak informally to athletes and in the case of minors, parents.

20. Force Majeure

"Force Majeure" means any act, event, omission, cause or circumstance not within the reasonable control of British Canoeing or the race organisers, including but not limited to any strike, lockout or other industrial action, any civil commotion or disorder, riot, invasion, war or terrorist activity or threat of war or terrorist activity, any action taken by a governmental or public authority of any kind (including, without limitation, not granting a consent, exemption, approval or clearance), any fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural physical disaster. In the event of such Force Majeure affecting the application of the policy, the IP shall have the sole discretion, in consultation with the British Canoeing Director of Governance, to make a decision in line with the principles, strategy and mission of this selection policy.

Page 9 DRAFT Canoe Sprint Junior Selection Policy 2024 - FOR PUBLIC CONSULTATION Appendix 1 – Performance Standard Data 2024 – International Panel Selection Guidance.

As per section 5, Performance Standards will be applied to all performances considered under the selection policy. This is to ensure a level of consistency to selections across classes and that all athletes are selected for the appropriate level of competition. Note that in an event where there are less than four boats contesting selection, the IP has sole discretion to select an athlete/crew based on available performance data.

The process for how performance standards will be applied:

- 1. The IP agrees the standard of the team as expressed as a minimum performance level. E.g., Ability to achieve a B final or better.
- 2. The IP collects all times from the relevant selection regatta and collates the % difference to World Leading Time for each event.
- 3. The IP collects weather information from the relevant selection regatta through the event.
- 4. The IP then uses available information to agree where the % of WLT will be set for that selection event, taking into account the above points.
- 5. The IP may adjust the standard applied to selections to reflect changing conditions during the regatta and the performance impact of conditions on different events.
- 6. The IP may adjust the standard applied for a particular event to reflect the most recent knowledge of performances within that event.

Whilst this process relies on objective data it is acknowledged that these decisions are ultimately subjective in nature.

The objective data used as guidance in decision making for the IP is shown in Table A and Table B below. Table A shows the Senior, U23 and Junior WLTs and the % difference between the Senior WLT and U23 and Junior WLTs. A comparison of the % differences can be used as part of the process to understand the performance standards.
