

# BRITISH CANOEING PRIVACY NOTICE FOR OUR JUNIOR MEMBERS, ATHLETES UNDER 18 AND TRAINING AND ASSESSMENT CANDIDATES UNDER 18

We at British Canoeing want to make sure all the personal details we hold about you are safe and secure, so we have put together this note to tell all of our junior members, whether you are a club paddler or a talent athlete, how we make sure we do that and what to do in case you have any questions for us or want to see what information we have. We are, what is known as, **a data controller.** This means we have control over how your details are used and who we pass them to.

Sometime organisations like ours need to appoint an individual called a "**Data Protection Officer**" to make sure that we are being very careful with your information. Our Data Protection Officer (DPO) is **Nancy Squires** and she can be contacted on <a href="mailto:nancy.squires@britishcanoeing.org.uk">nancy.squires@britishcanoeing.org.uk</a> if you have any questions.

#### 1. WHAT TYPE OF DETAILS DO WE COLLECT FROM YOU?

We might collect the following **personal details** about you before, during or after your time as a member, such as:

- details of how we can contact you, such as your name, email address, where you live and phone number;
- your birthday;
- your gender;
- membership details including when you signed up to be a member and any date you decide to leave us;
- all records of when you contacted us or we contacted you on the phone or by email or when you asked us to do something;
- o any bank details belonging to your parent or guardian so that we can receive payments from you and details of any payments you make;
- any images we capture at events, competitions, trainings and performance evaluations;
- o records that tell us when you were at our events or competitions; and
- o your hobbies, likes and dislikes so that we know what type of marketing we can send you.

Also, if you are one of junior who takes part in the sport competitively, we may also collect:

- your passport or other ID cards to verify your eligibility for age restricted competitions,
   Book flights where necessary; and/or take out insurance when travelling as a team member;
- records of whether you play at a club or at a regional/national level;
- details of family members, coaches and other people we might need to contact in case of an emergency;











- o records of your rankings, gradings or ratings, including any competition results, what races/events you have attended and how well you are performing on any development programme you are registered to;
- if you are on one of the talent programmes your school/higher education details;
- o any disciplinary information or details of any issues you have us or we have with you; and
- o any details we have on file to assess whether you are the right person to receive a scholarship or grant.

#### 2. SPECIAL INFORMATION

We may also hold and use what is called "special information" such as your race, background and which part of the world you or your family members are originally from, whether you have any religious beliefs, and any information about your health such as any injuries you have/have had or times you may not have been very well. In the table below, where we use this special information you will see this symbol \* and we will only use it if we have a really good reason to do so such as:

- o if it is in the interests of the public and we have a lawful reason to use it;
- o we need it to help us with a legal case we are involved in;
- certain laws allow us to use it; or
- o you have told us you are happy for us to use it.

In the table below we refer to these as the "special reasons".

# 3. WHERE DO WE GET THIS INFORMATION FROM?

Subject to the direction and consent given by your parent/ guardian/ carer we will normally collect personal information about you when you become a member of British Canoeing or to buy anything from us online or when you want to talk to us on the phone, by e-mail or in some other way.

If you are a paddler we also may collect details about you from any club you paddle at or from the teachers at your school or higher education institution. For example your club or school coach may have given us some information on your performance or results.

# 5. HOW CAN YOU STOP US FROM MARKETING TO YOU?

Sometimes we may wish to contact you by email, post or text message to tell you about things we think you might like. We will only do this if you have told us you are happy to receive these messages and you can tell us to stop at any time by letting us know us at <a href="mailto:gdpr@britishcanoeing.org.uk">gdpr@britishcanoeing.org.uk</a>. Also look out for the link at the bottom of any messages we send you which will allow you to put a stop to any messages.

# 6. WHO ELSE MAY USE YOUR DETAILS?

We may send your details to others to help us run our organisation. These are:

- O Anyone you have said you are happy for us to send your details to.
- To your club or another regional or governing body: to help us to improve and keep an
  eye on developments in the sport.
- Organisations that provide services to us: such as marketing specialists, the people who
  carry out research for us, computer services and the guys that help to run and maintain
  our security cameras;
- Organisations that help us; such as couriers, or companies that help us to deliver things to and from other parts of the country or overseas;
- Our Commercial Partners like Cotswold: so that we provide you with details on any tickets, special offers, opportunities, products and services and other benefits you get from our commercial partners as part of your membership package only where you have told us you want us to;
- The Government or our regulators: where the law tells us to do so or to help them with any investigations;
- Police, law enforcement and security services: to help them with any investigation, prevention of crime or matter of national security.

#### 7. ARE YOUR DETAILS SAFE?

We have put in place lots of security measures to make sure your details don't go missing or get used in a way they shouldn't be. We have a great team of people working with us who are trained to know how to use your details securely and will only use your details when and how we tell them to.











Did you know that all 'data controllers' based in the European Union and the UK like us are subject to laws that make sure that your personal details are safe? That is why we don't share your personal details to anyone outside of the UK and the European Union.

#### 8. HOW LONG DO WE KEEP PERSONAL INFORMATION FOR?

We collect personal details from you for different reasons and so we might keep it for different lengths of time. For example, we might have to keep it for a long time for legal reasons, but most of the time, we will keep your details for 10 years after you last get in touch with us.

It is important to make sure that the details we hold about you is accurate and up-to-date, so make sure you let us know if anything like your email address or phone number changes by contacting us at <a href="mailto:square: gdpr@britishcanoeing.org.uk">gdpr@britishcanoeing.org.uk</a>.

### 9. WHAT ARE YOUR RIGHTS?

Did you know you can ask us to do lots of things with your details?

You can ask us:

- o to tell you how your details are being used;
- o to provide you with a copy of all details we hold on you;
- to correct some of the details we hold if they are not correct or out of date like your contact details for example;
- o to delete all of the details we hold on you (unless we have a good reason not to!);
- o to stop using your details in a certain way;
- to send your details to you or another organisation like any club you participate at for example; and

Some of the rights may not always apply to the personal details we hold for you as there are sometimes requirements and exemptions attached which means we need to hold on to certain information and other times the rights may not apply at all.

**DON'T FORGET** though, if you have told us we can use your information in a certain way and you would like us to stop, you can tell us to stop at any time and you can always tell us to stop sending you marketing messages. ### 10. WHAT HAPPENS IF WE NEED TO CHANGE THIS NOTICE?

Keep an eye out for changes to this notice online. If we make big changes the version date at the bottom of the notice will be updated. Of course where we are required to do so by law, we will ask for your permission before we change the reason for using your details.
