

## **National Go Canoeing Week 2018 - Photography Competition**

### **Terms and Conditions**

**Entrants will be deemed to have accepted these terms and conditions, and agreed to be bound by them, when entering this Competition.**

#### **Prize:**

1. The winner of this competition will receive a Go-Pro Hero 5 action camera.
2. The prize as detailed above is available on the date of publication of these terms but British Canoeing reserves the right to change the prize on offer without notice.
3. The prize is non-transferable. No cash alternative can be claimed.
4. The prize must be claimed by December 31<sup>st</sup> 2018. After this date, claims will no longer be valid.
5. The delivery of the prize (if applicable) will be arranged once the winner has been contacted.

#### **Who may enter:**

6. This competition is open to residents of the UK, Channel Islands and Isle of Man, except for employees of British Canoeing.
7. This competition is open to all ages, but any entrant under 18 years of age requires parental consent to enter the competition before submitting their entry.

#### **How to enter:**

8. To be entered in this photo competition, all photos must be submitted to the competition through <http://www.gocanoeingweek.org.uk/>.
9. All photos uploaded to <http://www.gocanoeingweek.org.uk/> will be automatically entered to the Photo Competition and be subjected to the terms and conditions.
10. Only photos taken between the 26<sup>th</sup> May and 3<sup>rd</sup> June 2018 are eligible for entry. The closing date for entries will be 13<sup>th</sup> June 2018.
11. Late, illegible, incomplete, defaced or corrupt entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt. Entries must not be sent through agencies or third parties.

#### **Winner selection and notification:**

12. The winning entry will be the photo judged to be the most visually appealing, original and self-explanatory. The decision will be final, with no correspondence being entered into by British Canoeing in respect of any decision made by the judge.

13. The winner will be notified by the 13<sup>th</sup> July 2018.

**Copyright and Permissions:**

14. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. If the image subject is a child or children who are identifiable then parental permission must be obtained. Entrants must warrant that the photograph they are submitting is their own work and that they own the copyright for it.

15. Copyright in all images submitted for this competition remains with the respective entrants. However, in consideration of their providing the Competition, each entrant grants a royalty free, worldwide, irrevocable, perpetual licence to British Canoeing to feature any or all of the submitted images in any of their publications, their websites and/or in any promotional material connected to this competition.

16. Subject to prior written consent photo entries may be shared with British Canoeing's commercial partners for use in their promotional materials, website and/or publications.

**Personal Details:**

17. Personal data will be processed in accordance with the British Canoeing Data Protection policy and for the avoidance of doubt no data will be shared with third parties without express consent of the entrants and images will only be used in accordance with these terms and conditions.

**Liability:**

18. Events may occur that render the competition itself or the awarding of the prizes impossible due to reasons beyond the control of British Canoeing and accordingly British Canoeing may at its absolute discretion vary or amend the promotion and the entrant agrees that no liability shall attach to British Canoeing as a result thereof.

19. All information detailing how to enter the competition forms part of these terms and conditions. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules. The decision of the judges is final and no correspondence will be entered into. Submission of an entry will be taken to mean acceptance of these terms and conditions.
