

COACHING STRATEGY GROUP TERMS OF REFERENCE

1. Title

1.1 The Group shall be called the British Canoeing Coaching Strategy Group (CSG).

2. Accountability

2.1 CSG is accountable to the Board of British Canoeing for carrying out the responsibilities that are delegated to it within these Terms of Reference. The Board will manage this accountability in the following ways;

2.1.1 Approve the Terms of Reference and any changes to the Terms of Reference for CSG;

2.1.2 Receive and consider reports via the Coaching Strategy Group.

3. Purpose

3.1 The Purpose of CSG is to;

3.1.1 Determine and recommend to the British Canoeing Board a strategy/plan for British Canoeing Coaching and Leadership;

3.1.2 Effectively and efficiently lead, develop and manage the overall British Canoeing Coaching and Leadership strategy;

3.1.3 Determine how best British Canoeing should effectively and proactively respond to coaching policies and strategies from the UK Government, agencies and other organisations which affect British Canoeing Qualifications and Awards.

4. Responsibilities

4.1 CSG shall have the following responsibilities;

4.1.1 Identify and seek resources to support the development and implementation of the British Canoeing Coaching and Leadership plan;

4.1.2 Produce and manage a plan on how British Canoeing Qualifications and Awards will be developed and implemented over the UK and Internationally to a timetable and budget, as agreed by the British Canoeing Board;

4.1.3 Ensure that the British Canoeing Coaching governance and management structures can work effectively and efficiently with those in each of the National Associations;

4.1.4 Review, monitor and report on the effectiveness and efficiency of British Canoeing Qualifications and Awards to the British Canoeing Board;

4.1.5 Be made aware of the trends in paddlesport and advise the British Canoeing Board as to any proposed actions to support the Coaching and Leadership workforce that are needed to sustain and increase participation in all forms of paddlesport across the UK;

4.1.6 Advise the British Canoeing Board on new forms, derivatives and activities of paddlesport in the UK and how it can be included efficiently and effectively within the

membership, governance, management, performance, coaching and development functions of the British Canoeing, if thought appropriate to do so.

- 4.1.7 CSG will have the ability to set up sub-groups for specific work or projects, with the sub-group being accountable to CSG. A Terms of Reference will be set up for each sub-group.

5. Membership of CSG

- 5.1** CSG shall consist of the following Voting Members;

- 5.1.1 British Canoeing CEO - Chair
- 5.1.2 British Canoeing Head of Coaching and Qualifications
- 5.1.3 British Canoeing Head of Strategy and Development
- 5.1.4 British Canoeing Head of Performance Coaching
- 5.1.5 British Canoeing Awarding Body Committee Member
- 5.1.6 Canoe Association of North Ireland Coaching Representative
- 5.1.7 Canoe Wales Coaching Representative
- 5.1.8 English Coaching and Leadership Network Representative
- 5.1.9 Scottish Canoe Association Coaching Representative

- 5.2** In the absence of the British Canoeing CEO, the Head of Coaching and Qualifications will deputise.

- 5.3** CSG may co-opt additional members for a period not exceeding a year to provide specialist advice at the expense of the organisation, subject to budgets being agreed in advance by the Board.

- 5.4** It is expected that the National Associations will review their Representative every four years.

- 5.5** National Association Representatives will be appointed to CSG on the basis of having strengths in the following areas;

- 5.5.1 Knowledge of the appropriate paddler pathways (foundation to elite);
- 5.5.2 Strategic responsibility for coaching and coach development;
- 5.5.3 Ability to make decisions and commit to short-term agreed proposals;
- 5.5.4 Involvement in, and knowledge of, workforce planning and development at all levels of coaching and leadership;
- 5.5.5 Knowledge of the current organisational workforce involved in coaching and leadership in paddlesport in the UK;
- 5.5.6 Commitment to British Canoeing's organisational policies & procedures and ability to work within these policies;
- 5.5.7 Willingness to work in line with the Values of British Canoeing

6. Conflicts

- 6.1** British Canoeing is committed to upholding high standards of integrity and as such any

person who is part of CSG shall declare any conflicts or potential conflicts. If a person is unsure whether they have a conflict or potential conflict they should consult the Head of Governance and Compliance.

- 6.2** Decisions will usually be made by consensus. Where a vote is required, those with voting rights should be present in order to vote.

7. Meetings

- 7.1** CSG will meet at least three times a year. The Chair of CSG may convene additional meetings as they deem necessary.

- 7.2** Meeting dates shall usually be agreed at least 60 days in advance. Notices of meetings shall contain information relating to venue, time, date and agenda and shall usually be provided at least 7 days in advance.

- 7.3** The meetings may be held in person, by teleconference or video conference and individual members may join a physical meeting remotely via teleconference or video conference and be regarded as present at the meeting.

- 7.4** A minimum of five members of CSG must be present for the meeting to be deemed quorate.

- 7.5** Minute shall be taken to record the topics and discussion in the meeting but should not be attributed to individuals but will capture the collective decision of the group.

- 7.6** Draft minutes of the meeting shall usually be circulated to members of the group and made available within 14 days of the meeting. CSG minutes will be published and made available on the British Canoeing website.

8. Confidentiality

- 8.1** Any confidential information disclosed to CSG shall remain confidential until such point that the confidential information comes into the public domain.

9. Data Protection

- 9.1** 9.1 All personal data held by CSG in connection with qualifications and awards will be held in accordance with British Canoeing's Data Protection Policy and Privacy Notice.

10. Terms of reference and committee effectiveness

- 10.1** The Terms of Reference for CSG shall be reviewed every two years.
